



**125th FASNY Firemen's Home
Celebration/Muster/Parade
Application for a Permit to Camp**

Camping on the grounds of the FASNY Firemen's Home is allowed with a permit only. The camping area fee is \$40.00, payable by check to FASNY Firemen's Home. The campground opens at NOON on Friday, May 19, 2017. DO NOT plan to arrive prior to noon on May 19, 2017, as there will not be any early entry allowed for any reason. All campers must enter through the CAMPER Parking Gate entrance.

A copy of the Home's camping rules are included with this form, and must be adhered to at all times. Limited power and water hookups are available on a first-come-first serve basis. If your camping application is or is not accepted, you will be informed by mail within a month of receipt of your application. You will also be issued a permit when you check into the campground. This permit MUST be displayed on the driver's side dashboard at all times during your stay. To apply for a permit to camp at the FASNY Firemen's Home, please fill out this application form and return it with payment no later than April 20, 2017 to the address below. **Advanced camping registration is recommended, as there are a very limited number of sites available, and this is expected to be a very well attended event. Applications will be considered on a first-come-first-serve basis, and when the campground is full, there will be no further applications accepted, so we suggest you send this form with payment in as soon as possible.**

FASNY strictly prohibits smoking on all FASNY property inclusive of ALL indoor and outdoor areas.

Camping Rules



1. Absolutely no ATV's or golf carts permitted on FASNY Firemen's Home Grounds. (other than those used by staff and employees of the Home.)
2. Bicycles are not permitted, due to the high volume of traffic and Home Resident's safety.
3. No open fires are permitted! **Smoking of any kind is prohibited on the grounds.**
4. Possession of illegal drugs or firearms are not permitted on the property. The applicant's use of the premises shall comply with all applicable federal, state, and local Laws, Rules, and regulations.
5. Please keep excessive noise down to a minimum. The property may not be used in any manner that may create a nuisance which annoys, disturbs, or is injurious to health or offensive to the senses. The user shall not conduct himself/herself, or allow others to conduct themselves, in a manner that disrupts or disturbs the neighboring premises, or disrupts or disturbs the members of the Home.
6. Pets must be leashed or otherwise confined at all times. Pets are not permitted on the main grounds.
7. One camper or tent, plus one vehicle, is allowed per campsite. All other vehicles are to park in the parking area. All vehicles must obey the 15 mph speed limit on the grounds.
8. Campers are responsible for leaving the area clean. Trash dumpsters will be provided near the camp ground for your use. If you brought it in, take it out with you. Campsite needs to be cleaned up and vacated by 11:00 a.m. the day after your final night's stay.
9. Camper is responsible for the actions and any destruction caused by others who are traveling with or visiting while the camper is on FASNY Firemen's Home property.
10. Camper agrees to pay for any damage he/she causes to the premises. Camper agrees to hold harmless and indemnify the FASNY Firemen's Home, its officers, directors, and employees from and against any and all claims, demands, causes of action, liability, losses, damages, penalties, and expenses, including court costs and attorneys fees, arising from or incurred because of the camper's actual or alleged omissions with respect to the premises. The Camper assumes all risk of liability arising from or in connection with his/her use of the camping space and other activities at the premises and assumes and shall bear all risk of loss or damage to or theft or destruction of his/her equipment and personal property on the premises.
11. Camper must have the permit visible at all times. No camping without permit.
12. Parking is allowed only in designated areas. Failure to comply will result in vehicles being towed at the owner's expense.
13. FASNY activities have priority in the use of all facilities, and Board of Directors issuance of a permit may be made subject to or contingent upon certain requirements, matters or things, in the best interest of FASNY.
14. Use of campers and tents will be restricted to a maximum of 3 nights only for those families visiting or participating in approved FASNY activities. A signed camper's agreement application must be on file with the FASNY office.
15. In the event of bad weather or other hazardous conditions, a FASNY designated representative at his/her sole discretion may cancel or suspend such activity that could adversely affect FASNY grounds or structures, visitors, guests, employees etc.
